### Virginia Governor Volunteers at ALIVE!

Governor Bob McDonnell helped pack groceries in ALIVE!'s Family Emergency Program offices on September 27 in recognition of Hunger Action Month. The Governor's visit was coordinated with the Capital Area Food Bank (CAFB) as part of the Federation of Virginia Food Banks' invitation to local officials to raise awareness of hunger in their local communities by volunteering. Governor McDonnell grew up in the Alexandria area. The groceries he packed were delivered that afternoon to an Alexandria family in need.

The Governor met with ALIVE! President Cheryl Malloy, Executive Director Ken Naser, Food Program Chair Jean Moore, Board Member Vivian Webb as well as representatives of the CAFB, including Lynn Brantley its President and CEO, to discuss hunger issues and the importance of food banks and volunteer agencies like ALIVE! . "This is what we do well as Americans," the Governor said, "We help each other when people are in need."

### ALIVE! Welcomes 42<sup>nd</sup> Member Congregation

At their November meeting, ALIVE!'s Board of Directors voted to accept the organization's  $42^{nd}$  member congregation . Church of God and Saints of Christ, Sixteenth Tabernacle on Wythe Street in Alexandria was unanimously approved for membership by the ALIVE! Board.

I began talking to members of Sixteenth Tabernacle back in the Spring of 2011 when I was approached by Ms. Nataki MacMurray, a member of the congregation. In June, I met with Pastor James A. Parker, Ms. MacMurray and another trustee of the church to brief them on the many activities of ALIVE! Over the next few months, the trustees, officers and members of the congregation met and decided to seek membership.

In his letter to ALIVE!, Pastor Parker said "I lovingly refer to my congregation as the 'Special Forces' because we are able to deliver results disproportionate to our size. We are a congregation with an abundance of love and respect for God and our fellow man, demonstrated in our



### Home Delivery of Emergency Food - Truly a Community Effort!

ALIVE!'s Family Emergency Program (FEP) has dedicated volunteers who, every Monday through Friday, deliver bags of groceries to individuals and families in need in our city. But this year, for the first time in recent memory, volunteers from the business community have become a part of this all-important effort.

In the Spring of 2011, Federal Management Partners, a consulting firm headquartered in Alexandria's West End, which was already giving back to the community in several ways, began volunteering with FEP. Since then, the firm's employees,

working in teams of two, deliver our emergency food orders one day each month for which we are, indeed, grateful.

More recently, and in conjunction with Hunger Action Month and an AARP-sponsored food drive to benefit ALIVE!, three employees from AARP's Washington office volunteered at FEP on September 9th, packing and delivering that day's emergency food orders to hungry Alexandrians' homes. After making the deliveries, the three reported how

FEP, delivering emergency food to 19 low income families referred to us for help. Those volunteers received many hugs and "God Bless Yous" from the recipients and came away from the experience with a renewed awareness of the suffering and hardship so many Alexandrians endure, and an overwhelming appreciation for ALIVE! and its mission. One ExxonMobil volunteer reported how gratifying it was to help the recipients in such a direct and immediate way. ALIVE! is also greatly appreciative of a \$500 grant from ExxonMobil.

### IRA Charitable Rollover May Be Right for you!

The IRA Charitable Rollover was first enacted in 2006 as part of the Pension Protection Act of 2006 and has been reinstated for 2011. This law allows you to make a charitable gift directly from your IRA while excluding the amount of that gift from your adjusted gross income (AGI.)

- You must be 70-1/2 or older and required to make an annual distribution from your IRA. The IRA Charitable Rollover permits you to make donations directly to charitable organizations such as ALIVE! from your IRA without counting the distribution as part of your AGI and, consequently, without paying taxes on it.
- Your total combined charitable IRA rollover

- contribution cannot exceed \$100,000 in any one year.
- Charitable contributions from an IRA must go directly to ALIVE!.
- Distributions can only be made from traditional Individual Retirement Accounts or Roth IRAs.

We recommend that you seek advice from your accountant prior to making a charitable rollover as personal circumstances can have a significant impact on whether charitable rollovers are advantageous. In order to benefit from the 2010-eligible IRA contribution, contact your IRA administrator as soon as possible as some administrators may place a deadline on requesting transfers.

# **Student Success Story**

This spring, ALIVE!'s Child Development Center (CDC) was honored to achieve accreditation from the National Association for the Education of Young Children. This comes on top of a 4-star rating from the State of Virginia which was received in 2010. But what do these ratings really mean to the children entrusted to the CDC? The following is a report from a parent whose daughter, Keira, attended preschool at the CDC for two years and is now in kindergarten.

"Keira began attending ALIVE!'s CDC in 2009. As a parent I was nervous about her adjusting to new friends and teachers. The staff at the Center made Keira feel welcome right away. Her teacher began working with her on identifying letters and writing her name. Keira fell in love with Ms. RaIsha, and Ms. Charlene and was always at their sides. It was at the CDC that Keira learned how to work through her issues with friends 'using her words'.

In August 2010, Keira moved up to the Blue Room where she fell in love with Ms. Carrie, who really prepared Keira socially for kindergarten. Ms. Carrie also began working with Keira on her handwriting, because she was having difficulty (she is left handed). Ms. Carrie and Assistant Teacher Miss Shacola allowed Keira to be herself but at the same time focus on the tasks at hand.

I recently attended a conference with Keira's Kindergarten teacher. I am proud to say that Keira is doing exceptionally well in all areas. Her current teacher said how surprised she is that Keira is able to take responsibility for her own actions, is very social, and has a love for reading. I owe Kiera's excellent preparation for Kindergarten to the ALIVE! CDC."

The CDC serves children between the ages of 2 ½ and 5 years of age and their working parents. Most of the children at the CDC are considered "at risk" and almost all receive some tuition assistance so that the family can afford a quality preschool education. It is a full-day, year-around program for up to 38 children.
